Personal, Social, Health and Economic (PSHE) Policy

Our vision is to create a peaceful, nurturing Christian school community where everyone knows they belong. Our inclusive approach ensures that everyone is valued, has high aspirations and given opportunities to flourish in every area of life.

Our motto is 'Flourishing together, with God as our firm foundation'.

<u>Context</u>

All schools must provide a curriculum that is broadly based, balanced and meets the needs of all pupils. Under section 78 of the Education Act 2002 and the Academies Act 2010, a PSHE curriculum:

 \cdot Promotes the spiritual, moral, cultural, mental and physical development of pupils at the school and of society, and

· Prepares pupils at the school for the opportunities, responsibilities and experiences of later life.

This policy meets the requirements that schools publish a Relationships and Sex Education policy and does this within the wider context of Personal, Social and Health Education.

PSHE

At The Walsh Schools, we teach Personal, Social, Health Education as a whole-school approach to underpin children's development as people and because we believe that this also supports their learning capacity.

The Jigsaw Programme offers us a comprehensive, carefully thought-through Scheme of Work which brings consistency and progression to our children's learning in this vital curriculum area. The overview of the programme can be seen on the school website.

This also supports the "Personal Development" and "Behaviour and Attitude" aspects evaluated under the Ofsted Inspection Framework, as well as significantly contributing to the school's Safeguarding and Equality Duties, the Government's British Values agenda and the SMSC (Spiritual, Moral, Social, Cultural) development opportunities provided for our children.

To ensure progression and a spiral curriculum, we use Jigsaw, the mindful approach to PSHE, as our chosen teaching and learning programme and tailor it to children's needs. The mapping document: Jigsaw 3-11 and statutory Relationships and Health Education, <u>jigsaw-3-11-and-rshe-overview-map.pdf</u> shows exactly how Jigsaw and therefore our school, meets the statutory Relationships and Health Education requirements.

This programme's complimentary update policy ensures we are always using the most up to date teaching materials and that our teachers are well-supported.

What do we teach when and who teaches it?

Whole-school approach

Jigsaw covers all areas of PSHE for the primary phase including statutory Relationships and Health Education. The table below gives the learning theme of each of the six Puzzles (units) and these are taught across the school; the learning deepens and broadens every year.

At The Walsh Schools we allocate one hour to PSHE each week in order to teach the PSHE knowledge and skills in a developmental and age-appropriate way.

These explicit lessons are reinforced and enhanced in many ways:

Assemblies and collective worship, praise and reward system, Jigsaw Charter, The whole school Thrive approach, Zones of Regulation and through relationships child to child, adult to child and adult to adult across the school. We aim to 'live' what is learnt and apply it to everyday situations in the school community.

Class teachers deliver the weekly lessons to their own classes.

Relationships Education

What does the DfE statutory guidance on Relationships Education expect children to know by the time they leave primary school?

Relationships Education in primary schools will cover 'Families and people who care for me', 'Caring friendships', 'Respectful relationships', 'Online relationships', and 'Being safe'.

The expected outcomes for each of these elements can be found further on in this policy. The way the Jigsaw Programme covers these is explained in the mapping document: Jigsaw 3-11 and Statutory Relationships and Health Education.

It is important to explain that whilst the Relationships Puzzle (unit) in Jigsaw covers most of the statutory Relationships Education, some of the outcomes are also taught elsewhere in Jigsaw e.g. the Celebrating Difference Puzzle helps children appreciate that there are many types of family composition and that each is important to the children involved. This holistic approach ensures the learning is reinforced through the year and across the curriculum.

Parents should also be aware that the Church of England states in "Valuing All God's Children", 2019, that Relationships and Sex education should: "Make it clear that relationships and sex education is designed to prepare all pupils for the future, regardless of sexual orientation or gender identity. RSE must promote gender equality and LGBT equality and it must challenge discrimination. RSE must take the needs and experiences of LGBT people into account and it should seek to develop understanding that there are a variety of relationships and family patterns in the modern world." (Page 34)

Health Education

What does the DfE statutory guidance on Health Education expect children to know by the time they leave primary school?

Health Education in primary schools will cover 'Mental wellbeing', 'Internet safety and harms', Physical health and fitness', Healthy eating', 'Drugs, alcohol and tobacco', 'Health and prevention', 'Basic First Aid', 'Changing adolescent body'.

The expected outcomes for each of these elements can be found further on in this policy. The way the Jigsaw Programme covers these is explained in the mapping document: Jigsaw 3-11 and Statutory Relationships and Health Education.

It is important to explain that whilst the Healthy Me Puzzle (unit) in Jigsaw covers most of the statutory Health Education, some of the outcomes are taught elsewhere in Jigsaw e.g. emotional and mental health is nurtured every lesson through the Calm me time, social skills are grown every lesson through the Connect us activity and respect is enhanced through the use of the Jigsaw Charter.

Also, teaching children about puberty is now a statutory requirement which sits within the Health Education part of the DfE guidance within the 'Changing adolescent body' strand, and in Jigsaw this is taught as part of the Changing Me Puzzle (unit).

Again, the mapping document transparently shows how the Jigsaw whole-school approach spirals the learning and meets all statutory requirements and more.

Sex Education

The DfE Guidance 2019 (p.23) recommends that all primary schools 'have a sex education programme tailored to the age and the physical and emotional maturity of the pupils.

However, 'Sex Education is not compulsory in primary schools'. (p. 23)

Schools are to determine the content of sex education at primary school. Sex education 'should ensure that both boys and girls are prepared for the changes that adolescence brings and – drawing on knowledge of the human life cycle set out in the national curriculum for science - how a baby is conceived and born'.

At The Walsh Schools, we believe children should understand the facts about human reproduction before they leave primary school so we intend to teach this as part of our PSHE curriculum before the transition to secondary school.

We define Sex Education as the understanding human reproduction process, from conception to birth.

We intend to teach this in part through Science, but with the additional coverage as part of PSHE and the Jigsaw curriculum.

Parents' right to request their child be excused from Sex Education

"Parents have the right to request that their child be withdrawn from some or all of sex education delivered as part of statutory Relationships and Sex Education" DfE Guidance p.17

At The Walsh Schools, puberty is taught as a statutory requirement of Health Education and covered by our Jigsaw PSHE Programme in the 'Changing Me' Puzzle (unit). We conclude that sex education refers to Human Reproduction, and therefore inform parents of their right to request their child be withdrawn from the PSHE lessons that explicitly teach this i.e. the Jigsaw Changing Me Puzzle (unit) e.g.

Year 4, Lesson 2 (Having a baby) Year 5, Lesson 4 (Conception) Year 6, Lesson 3 (Conception, birth)

We teach about puberty, conception, and birth in the Summer Term as part of the PSHE/RSE curriculum) by using elements of the Jigsaw programme. You will be notified of when and what we will be teaching by your child's class teacher. We supplement these Jigsaw resources by using the 4 Learning 'All About Us: Living and Growing – Alternative' videos in Year 6.

As the teaching of puberty is delivered as part of the science curriculum in Year 5, parents do not have a right to withdraw their child from these sessions. However, we are of course happy to discuss the content of the curriculum and invite parents to contact their class teacher for further information.

We always consult parents about sex education lessons prior to them being taught in Year 6. Parents have an opportunity to look at materials and watch videos in advance. As these lessons are taught as part of PSHE/RSE, parents do have a right to withdraw their child from these sessions. "Parents have the right to request that their child be withdrawn from some or all of sex education delivered as part of statutory Relationships and Sex Education" DfE Guidance p.17. However, we do advise parents that these sessions are important in helping children to learn not only about bodily changes and human reproduction, but also about healthy relationships in an accurate and supportive way.

The school will inform parents of this right by notifying them of updates to this policy and displaying it on the school website. A supplementary leaflet provided by Jigsaw will also be available on the school website to outline the guidance on RSHE and the curriculum.

We are more than happy to discuss the contents of the PSHE curriculum with parents to achieve the outcomes for all parties and to provide the best education possible whilst respecting the wishes of the parents.

Monitoring and Review

The Local Committee will approve the RSHE policy annually. The Local Committee delegate the responsibility for implementation of this policy to the Headteacher. The Headteacher is responsible for ensuring that RSHE is taught consistently across the school, and for managing requests to withdraw pupils from non-statutory components of RSHE.

Equality

This policy will inform the school's Equalities Plan.

The DfE Guidance 2019 (p. 15) states, "Schools should ensure that the needs of all pupils are appropriately met, and that all pupils understand the importance of equality and respect. Schools must ensure they comply with the relevant provisions of the Equality Act 2010 under which sexual orientation and gender reassignment are amongst the protected characteristics...

At the point at which schools consider it appropriate to teach their pupils about LGBT (Lesbian, Gay, Bisexual, Transgender), they should ensure this content is fully integrated into their programmes of study for this area of the curriculum rather than delivered as a stand-alone unit or lesson. Schools are free to determine how they do this, and we expect all pupils to have been taught LGBT content at a timely point as part of this area of the curriculum".

This can also have an impact on any anti-bullying policies in regard to these characteristics being the reason for the issue. The Church of England document "Valuing all God's Children", 2019, states: "Schools should ensure that they have clear anti-bullying policies on preventing and tackling homophobic, biphobic and transphobic behaviour and language and that these policies are known and understood by all members of the school community. School leaders should present a clear message that HBT bullying will not be tolerated and that there can be no justification for this negative behaviour based on the Christian faith or the Bible. Schools should ensure that pupils understand how to report incidents. Pupils should be confident that if they report bullying it will be taken seriously."

It also asserts:

"Central to Christian theology is the truth that every single one of us is made in the image of God. Every one of us is loved unconditionally by God. We must avoid, at all costs, diminishing the dignity of any individual to a stereotype or a problem. Church of England schools offer a community where everyone is a person known and loved by God, supported to know their intrinsic value" (page 1)

"Opportunities to discuss issues to do with self-esteem, identity and bullying, including HBT (homophobic, biphobic and transphobic) bullying, should be included in physical, social, health and economic education or citizenship programmes. The curriculum should offer opportunities for pupils to learn to value themselves and their bodies. Relationships and sex education should take LGBT people into account." (Page 6) At The Walsh Schools we promote respect for all and value every individual child. We also respect the right of our children, their families and our staff, to hold beliefs, religious or otherwise, and understand that sometimes these may be in tension with our approach to some aspects of

Relationships, Health and Sex Education.

Inclusive teaching

We split girls and boys when teaching and aim, where possible to have a male present for boys.

We will send out clear communication to all parents and clearly state what parts parents are able to withdraw from (birth and conception) and have further discussions with parents where needed.

We are aiming to open up our Year 6 parent workshop to other years so families are well informed.

Confidentiality and Advice

Pupils will be made aware that some information cannot be held confidential and that if certain disclosures are made, certain actions will take place. At the same time pupils will be offered sensitive and appropriate support.

Child Protection and safeguarding

Any child protection concerns should be referred to one of the Designated Safeguarding Lead (DSL). DSLs are trained in all aspects of child abuse and the necessary procedures that must be followed. (Please see the Child Protection and Safeguarding Children Policy).

Through effective Relationships and Health Education we aim to ensure that all pupils are well equipped to develop positive relationships and awareness of keeping themselves safe in the future. We leave them vulnerable, if we do not do everything we can to equip them to keep themselves safe both inside and outside of school. We safeguard our children effectively through teaching these valuable life skills during Life Learning lessons. Our comprehensive, broad and balanced curriculum uses the Jigsaw scheme and has overarching concepts that are developed through our PSHE teaching.

Assessment

- Assessment of this subject takes place half-termly.
- Teachers assess against the objectives set out for the half term.
- Teachers use 'greater depth', 'expected', 'working towards' and 'working below year group' to record how well the child achieved the expected outcomes at the point in time of assessment.
- This assessment helps teachers to identify if there are any children who need some extra provision or more coverage on a particular area.
- This assessment process helps us to safeguard our children in a holistic sense by ensuring they have acquired the skills they need.
- Subject leads monitor assessments to identify learners who require further support as they transition to their next year group.

Relationships Education in Primary schools – DfE Guidance 2019

The focus in primary school should be on teaching the fundamental building blocks and characteristics of positive relationships, with particular reference to friendships, family relationships, and relationships with other children and with adults. The references R3/H5 etc can be cross-referenced on the Jigsaw mapping documents and Puzzle Maps to show which lessons throughout Jigsaw contribute to which statutory outcomes. All statutory outcomes are covered in the Jigsaw 3-11 Programme.

The guidance states that, by the end of primary school:

Physical health and mental well-being education in Primary schools - DfE Guidance

The focus in primary school should be on teaching the characteristics of good physical health and mental wellbeing. Teachers should be clear that mental well-being is a normal part of daily life, in the same way as physical health.

By the end of primary school:
